**A BILL**

To amend the Consolidated Farm and Rural Development Act to reauthorize and expand the Rural Innovation Stronger Economy grant program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Innovation  
5 Stronger Economy (RISE) Reauthorization Act of 2024”.

1 **SEC. 2. RURAL INNOVATION STRONGER ECONOMY GRANT**  
2 **PROGRAM REAUTHORIZATION AND EXPAN-**  
3 **SION.**

4 (a) IN GENERAL.—Section 379I of the Consolidated  
5 Farm and Rural Development Act (7 U.S.C. 2008w) is  
6 amended—

7 (1) in subsection (a)—

8 (A) in paragraph (1)—

9 (i) in subparagraph (A)(i)—

10 (I) by striking “the industry clus-

11 ters that are objectively identified as”;

12 and

13 (II) by inserting “industries in

14 the area served by the partnership”

15 after “declining”; and

16 (ii) in subparagraph (B)(ii)—

17 (I) by striking subclause (I); and

18 (II) by redesignating subclauses

19 (II) through (IV) as subclauses (I)

20 through (III), respectively;

21 (B) by striking paragraph (2); and

22 (C) by redesignating paragraphs (3)

23 through (5) as paragraphs (2) through (4), re-

24 spectively;

25 (2) in subsection (b)—

26 (A) in paragraph (1)—

1 (i) by redesignating subparagraphs  
2 (A) and (B) as clauses (i) and (ii), respec-  
3 tively, and indenting the clauses appro-  
4 priately;

5 (ii) in clause (ii) (as so redesignated),  
6 by striking “opportunities, networks, and  
7 industry clusters” and inserting “opportu-  
8 nities and networks”;

9 (iii) by striking the paragraph des-  
10 ignation and heading and all that follows  
11 through “The Secretary” in the matter  
12 preceding clause (i) (as so redesignated)  
13 and inserting the following:

14 “(1) GRANT PROGRAM.—

15 “(A) IN GENERAL.—The Secretary”; and

16 (iv) by adding at the end the fol-  
17 lowing:

18 “(B) TARGETED COMMUNITY TYPES.—In  
19 carrying out the grant program under this  
20 paragraph, the Secretary shall—

21 “(i) target a broad base of rural com-  
22 munity types that will benefit from the  
23 program, with an emphasis on commu-  
24 nities with a population of fewer than  
25 20,000 inhabitants; and

1           “(ii) of the total amount of grants  
2           awarded for each fiscal year, award not  
3           less than 10 percent to carry out activities  
4           that will benefit rural communities with a  
5           population of fewer than 10,000 inhab-  
6           itants.”; and

7           (B) in paragraph (3)—

8           (i) in subparagraph (A)—

9           (I) by redesignating clauses (i)  
10           and (ii) as subclauses (I) and (II), re-  
11           spectively, and indenting the sub-  
12           clauses appropriately; and

13           (II) in subclause (II) (as so re-  
14           designated), by striking “industry  
15           cluster”;

16           (ii) by striking subparagraph (C);

17           (iii) in subparagraph (D), by striking  
18           “industry clusters,”;

19           (iv) by redesignating subparagraphs  
20           (A), (B), (D), (E), and (F) as clauses (i),  
21           (ii), (iii), (iv), and (v), respectively, and in-  
22           denting the clauses appropriately; and

23           (v) in the matter preceding clause (i)  
24           (as so redesignated), by striking “shall

1 consider—” and inserting the following:

2 “shall—

3 “(A) ensure that a diverse set of industry  
4 bases is represented;

5 “(B) only select an eligible entity to receive  
6 a grant with the concurrence of the applicable  
7 State office of the rural development mission  
8 area; and

9 “(C) take into consideration—”;

10 (3) in subsection (d)(1)—

11 (A) in subparagraph (A), by adding “and”  
12 after the semicolon at the end; and

13 (B) in subparagraph (B)—

14 (i) in clause (i), by striking “industry  
15 clusters,”;

16 (ii) in clause (vii), by striking “small  
17 businesses in regional industry clusters, in-  
18 cluding”;

19 (iii) in clause (ix), by striking “in the  
20 identified industry clusters”; and

21 (iv) in clause (x), by striking “indus-  
22 try cluster”;

23 (4) in subsection (e)(2)(B)—

24 (A) in clause (viii)—

1 (i) in subclause (I), by striking “in-  
2 industry cluster” and inserting “activities  
3 funded with the grant”; and

4 (ii) in subclause (II), by striking “held  
5 by the industry cluster” and inserting “re-  
6 lating to those activities convened by rel-  
7 evant organizations”;

8 (B) in clauses (xi) and (xii), by striking  
9 “industry cluster” each place it appears and in-  
10 sserting “participating regional”; and

11 (C) in clause (xiii), by striking “the project  
12 activities” and inserting “activities funded with  
13 the grant”; and

14 (5) by striking subsection (f) and inserting the  
15 following:

16 “(f) AUTHORIZATION OF APPROPRIATIONS.—There  
17 are authorized to be appropriated to carry out this sec-  
18 tion—

19 “(1) \$10,000,000 for each of fiscal years 2019  
20 through 2024; and

21 “(2) \$50,000,000 for each of fiscal years 2025  
22 through 2029.”.

23 (b) CONFORMING AMENDMENT.—Section  
24 6306(h)(3)(B)(ii) of the Agriculture Improvement Act of  
25 2018 (7 U.S.C. 2204b–3(h)(3)(B)(ii)) is amended, in the

1 matter preceding subclause (I), by striking “section  
2 379I(a)(4) of the Consolidated Farm and Rural Develop-  
3 ment Act” and inserting “section 379I(a) of the Consoli-  
4 dated Farm and Rural Development Act (7 U.S.C.  
5 2008w(a))”.
