A BILL

To create a National Science Foundation scholarship-forservice Humanitarian Tech Corps, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Humanitarian Tech
- 5 Corps Act".
- 6 SEC. 2. SENSE OF CONGRESS.
- 7 It is the sense of Congress that the Federal Govern-
- 8 ment must broadly invest in the technological innovation
- 9 and talent pipeline of the United States, in a manner that
- 10 is beyond traditional focus areas, in order to—

1	(1) develop public interest technology expertise;
2	and
3	(2) ensure Federal agencies, especially agencies
4	tasked with critical humanitarian missions, have the
5	capacity to uniquely and meaningfully leverage lead-
6	ing-edge technology to improve their operations.
7	SEC. 3. FEDERAL HUMANITARIAN TECHNOLOGY SCHOLAR-
8	SHIP-FOR-SERVICE PROGRAM.
9	(a) Definitions.—In this section:
10	(1) Administrator.—The term "Adminis-
11	trator" means the Administrator of the United
12	States Agency for International Development.
13	(2) COVERED DEGREE.—The term "covered de-
14	gree" means a baccalaureate or postgraduate degree
15	that is in—
16	(A) computer science;
17	(B) data science or data analytics; or
18	(C) any other science, technology, engi-
19	neering, or mathematics field that, as deter-
20	mined by the Administrator under subsection
21	(j)(1)(A) and shared with the Director for pro-
22	gram facilitation, enables humanitarian oper-
23	ations and technology-related modernization ef-
24	forts.

1	(3) COVERED POSITION.—The term "covered
2	position", when used with respect to a scholarship
3	recipient, means a position of employment (including
4	a civil service or foreign service position with a
5	qualifying agency)—
6	(A) for which the scholarship recipient is
7	qualified;
8	(B) that—
9	(i) requires a covered degree; or
10	(ii) does not explicitly require a cov-
11	ered degree but, as determined by the Ad-
12	ministrator under subsection (j)(1)(A)(ii)
13	and shared with the Director for program
14	facilitation, directly supports strictly hu-
15	manitarian operations, such as an analysis,
16	management, or executive position or an-
17	other operational position that provides
18	such direct support; and
19	(C) that is with a qualifying agency or a
20	qualifying organization or nongovernmental
21	agency.
22	(4) DIRECTOR.—The term "Director" means
23	the Director of the National Science Foundation.
24	(5) Eligible student.—The term "eligible
25	student" means an individual who—

1	(A) is a citizen of the United States; and
2	(B) is a full-time student enrolled in a pro-
3	gram of study leading to a covered degree at a
4	qualifying institution.
5	(6) Humanitarian tech corps scholar-
6	SHIP.—The term "Humanitarian Tech Corps schol-
7	arship" means a scholarship described in subsection
8	(e)(1).
9	(7) QUALIFYING AGENCY.—The term "quali-
10	fying agency" means—
11	(A) the United States Agency for Inter-
12	national Development; or
13	(B) another agency, as determined by the
14	Administrator under subsection $(j)(1)(B)$ and
15	shared with the Director for program facilita-
16	tion.
17	(8) QUALIFYING INSTITUTION.—The term
18	"qualifying institution" means an institution of
19	higher education, as defined in section 101(a) of the
20	Higher Education Act of 1965 (20 U.S.C. 1001(a)).
21	(9) Qualifying organization or non-
22	GOVERNMENTAL AGENCY.—The term "qualifying or-
23	ganization or nongovernmental agency" means an
24	organization or nongovernmental agency identified

1	by the Administrator under subsection $(j)(1)(C)$ and
2	shared with the Director for program facilitation.
3	(10) SCHOLARSHIP RECIPIENT.—The term
4	"scholarship recipient" means an eligible student
5	who receives a Humanitarian Tech Corps scholar-
6	ship and enters into an agreement under subsection
7	(e).
8	(b) Program Established.—The Director, in co-
9	ordination with the Director of the Office of Personnel
10	Management and the Administrator, shall establish a Fed-
11	eral humanitarian technology scholarship-for-service pro-
12	gram (referred to in this section as the "Humanitarian
13	Tech Corps Program") to recruit and train the next gen-
14	eration of professionals needed to meet the humanitarian
15	technology needs of the Federal Government.
16	(e) Program Description and Components.—
17	The Humanitarian Tech Corps Program shall—
18	(1) award grants, contracts, or cooperative
19	agreements to qualifying institutions of higher edu-
20	cation to enable the qualifying institutions to provide
21	Humanitarian Tech Corps scholarships to eligible
22	students;
23	(2) in consultation with the United States
24	Agency for International Development, provide the
25	scholarship recipients with summer internship oppor-

1	tunities or other meaningful temporary appoint
2	ments serving humanitarian purposes in qualifying
3	agencies or qualifying organizations or nongovern
4	mental agencies; and
5	(3) prioritize the placement of scholarship re
6	cipients fulfilling the post-award employment obliga
7	tion under this section in covered positions in a
8	manner that ensures—
9	(A) for not less than the first year of such
10	post-award employment obligation required
11	under subsection (e)(1)(A), all scholarship re
12	cipients are placed in a covered position with a
13	qualifying agency; and
14	(B) that after the completion of the first
15	year of such employment obligation, scholarship
16	recipients may obtain employment in covered
17	positions at a qualifying organization or non
18	governmental agency.
19	(d) Scholarship Amounts; Scholarship Recipi
20	ENT SELECTION.—
21	(1) Scholarship amounts.—Each Humani
22	tarian Tech Corps scholarship shall be in an amoun
23	that covers the scholarship recipient's tuition and
24	fees at the qualifying institution under subsection
25	(c)(1) for not more than 4 years and provides the

1	scholarship recipient with an additional living sti-
2	pend.
3	(2) Selection.—In selecting eligible students
4	to receive Humanitarian Tech Corps scholarships, a
5	qualifying institution participating in the Humani-
6	tarian Tech Corps program shall not exclusively con-
7	sider the technical background or prior education of
8	the eligible students, but shall also take into consid-
9	eration other experiences of the eligible students
10	that may transfer well to humanitarian work.
11	(e) AGREEMENT.—
12	(1) In general.—As a condition of receiving a
13	Humanitarian Tech Corps scholarship, an eligible
14	student shall enter into an agreement with the quali-
15	fying institution providing the scholarship under
16	which the eligible student receiving the scholarship—
17	(A) agrees to work for a period equal to
18	the duration of the scholarship, following re-
19	ceipt of the student's degree, in a covered posi-
20	tion;
21	(B) accepts and acknowledges the condi-
22	tions of support under paragraph (2); and
23	(C) accepts the repayment requirements
24	under subsection (f) and all other terms and

1	conditions of the Humanitarian Tech Corps
2	scholarship.
3	(2) Conditions of support.—
4	(A) Provision of documentation and
5	CONTACT INFORMATION.—As a condition of re-
6	ceiving a Humanitarian Tech Corps scholar-
7	ship, an eligible student shall agree to provide
8	the Office of Personnel Management (in coordi-
9	nation with the National Science Foundation)
10	and the qualifying institution with annual
11	verifiable documentation of post-award employ-
12	ment and up-to-date contact information.
13	(B) Other conditions.—A scholarship
14	recipient shall be liable to the United States as
15	provided under subsection (f) if the individual—
16	(i) fails to maintain an acceptable
17	level of academic standing, as determined
18	by the Director, at the applicable quali-
19	fying institution;
20	(ii) is dismissed from such qualifying
21	institution for disciplinary reasons;
22	(iii) withdraws from the covered de-
23	gree program before completing the pro-
24	gram;

1	(iv) declares that the individual does
2	not intend to fulfill the post-award employ-
3	ment obligation under this section;
4	(v) fails to maintain or fulfill any of
5	the post-graduation or post-award obliga-
6	tions or requirements of the individual; or
7	(vi) fails to fulfill the requirements of
8	subparagraph (A).
9	(f) Repayment.—
10	(1) Amount of Repayment.—
11	(A) Less than 1 year of service.—If a
12	circumstance described in subsection $(e)(2)(B)$
13	occurs before the completion of 1 year of a
14	post-award employment obligation under this
15	section, the total amount of scholarship awards
16	received by the individual under this section
17	shall—
18	(i) be repaid; or
19	(ii) be treated as a loan to be repaid
20	in accordance with paragraph (3).
21	(B) 1 or more years of service.—If a
22	circumstance described in clause (iv) or (v) of
23	subsection (e)(2)(B) occurs after the completion
24	of 1 or more years of a post-award employment
25	obligation under this section, the total amount

1	of scholarship awards received by the individual
2	under this section, reduced by the ratio of the
3	number of years of service completed divided by
4	the number of years of service required, shall—
5	(i) be repaid; or
6	(ii) be treated as a loan to be repaid
7	in accordance with paragraph (3).
8	(2) Collection of Repayment.—
9	(A) IN GENERAL.—In the event that a
10	scholarship recipient is required to repay a Hu-
11	manitarian Tech Corps scholarship award, the
12	qualifying institution providing the scholarship
13	shall—
14	(i) determine the repayment amount
15	and notify the recipient, the Director, and
16	the Director of the Office of Personnel
17	Management of the amount owed; and
18	(ii) collect the repayment amount
19	within a reasonable period of time, as de-
20	termined by the Director, or treat the re-
21	payment amount as a loan in accordance
22	with paragraph (3).
23	(B) RETURNED TO TREASURY.—
24	(i) In general.—Except as provided
25	in clause (ii), any repayment collected

1	under this paragraph shall be returned to
2	the Treasury of the United States.
3	(ii) Retained Percentage.—A
4	qualifying institution may retain a percent-
5	age of any repayment the institution col-
6	lects under this subsection to defray ad-
7	ministrative costs associated with the col-
8	lection. The Director shall establish a sin-
9	gle, fixed percentage that will apply to all
10	qualifying institutions of higher education
11	under this section.
12	(3) Loan treatment.—A loan described in
13	subparagraph (A)(ii) or (B)(ii) of paragraph (1)
14	shall—
15	(A) be treated as a Federal Direct Unsub-
16	sidized Stafford Loan under part D of title IV
17	of the Higher Education Act of 1965 (20
18	U.S.C. 1087a et seq.); and
19	(B) be subject to repayment, together with
20	interest thereon accruing from the date of the
21	scholarship award, in accordance with terms
22	and conditions specified by the Director (in con-
23	sultation with the Secretary of Education) in
24	regulations promulgated to carry out this sub-
25	section.

1	(4) Exceptions.—The Director may provide
2	for the partial or total waiver or suspension of any
3	service or payment obligation by a scholarship recipi-
4	ent—
5	(A) whenever compliance by the scholar-
6	ship recipient with the obligation is impossible
7	or would involve extreme hardship to the schol-
8	arship recipient; or
9	(B) if enforcement of such obligation with
10	respect to the scholarship recipient would be
11	unconscionable.
12	(g) Monitoring Compliance.—As a condition of
13	participating in the program, a qualifying institution
14	shall—
15	(1) enter into an agreement with the Director
16	to monitor the compliance of scholarship recipients
17	with respect to their post-award employment obliga-
18	tions; and
19	(2) provide to the Director and the Director of
20	the Office of Personnel Management, on an annual
21	basis, the post-award employment documentation re-
22	quired under subsection (e)(2)(A) for scholarship re-
23	cipients supported by the qualifying institution, dur-
24	ing the period beginning upon the receipt of the Hu-
25	manitarian Tech Corps scholarship and ending upon

the completion of the scholarship recipient's postaward employment obligations.

(h) Hiring Authority.—

- (1) Appointment in excepted service.—
 Notwithstanding any provision of chapter 33 of title
 5, United States Code, governing appointments in
 the competitive service, a qualifying agency shall appoint in the excepted service an individual who has
 completed the eligible degree program for which a
 scholarship was awarded.
- (2) Noncompetitive conversion.—Except as provided in paragraph (4), upon fulfillment of the service term, an employee appointed under paragraph (1) may be converted noncompetitively to term, career-conditional, or career appointment.
- (3) TIMING OF CONVERSION.—A qualifying agency may noncompetitively convert a term employee appointed under paragraph (2) to a career-conditional or career appointment before the term appointment expires.
- (4) Authority to decline conversion.—A qualifying agency may decline to make the non-competitive conversion or appointment under paragraph (2) for cause.
- 25 (i) Public Information.—

1	(1) EVALUATION.—The Director, in coordina-
2	tion with the Director of the Office of Personnel
3	Management, shall periodically evaluate and make
4	public, in a manner that protects the personally
5	identifiable information of scholarship recipients, in-
6	formation on the success of recruiting individuals for
7	scholarships under this section and on hiring and re-
8	taining those individuals in the humanitarian tech-
9	nology workforce, including information on—
10	(A) placement rates;
11	(B) where students are placed, including
12	job titles and descriptions;
13	(C) salary ranges for students not released
14	from obligations under this section;
15	(D) how long after graduation students are
16	placed;
17	(E) how long students stay in the positions
18	they enter upon graduation;
19	(F) how many students are released from
20	obligations; and
21	(G) what, if any, remedial training is re-
22	quired.
23	(2) Reports.—The Director, in coordination
24	with the Office of Personnel Management, shall sub-
25	mit, not less frequently than once every 2 years, to

1	the Committee on Commerce, Science, and Trans-
2	portation and the Committee on Homeland Security
3	and Governmental Affairs of the Senate and the
4	Committee on Science, Space, and Technology and
5	the Committee on Oversight and Accountability of
6	the House of Representatives, a report that in-
7	cludes—
8	(A) the results of the evaluation under
9	paragraph (1);
10	(B) an explanation of any disparity in re-
11	porting between scholarship recipients and their
12	respective qualifying institutions; and
13	(C) any recent statistics regarding the size,
14	composition, and educational requirements of
15	the Federal humanitarian technology workforce.
16	(3) Resources.—The Director, in coordination
17	with the Director of the Office of Personnel Manage-
18	ment, shall provide consolidated and user-friendly
19	online resources for prospective scholarship recipi-
20	ents, including, to the extent practicable—
21	(A) searchable, up-to-date, and accurate
22	information about participating qualifying insti-
23	tutions and job opportunities related to Hu-
24	manitarian Tech Corps scholarships; and

1	(B) a description of humanitarian careers
2	for science, technology, mathematics, or engi-
3	neering students.
4	(j) Administrative Responsibilities.—
5	(1) USAID ADMINISTRATOR DUTIES.—
6	(A) Decisions regarding humani-
7	TARIAN OPERATIONS.—By not later than 180
8	days after the date of enactment of this Act,
9	the Administrator, after consultation with the
10	Director, shall—
11	(i) define the concepts of "humani-
12	tarian operations" and "technological mod-
13	ernization efforts" for purposes of sub-
14	section $(a)(2)(C)$;
15	(ii) determine which positions directly
16	support humanitarian operations for pur-
17	poses of subsection (a)(3)(B)(ii); and
18	(iii) identify the covered degrees that
19	the Administrator determines meet the re-
20	quirements of subsection (a)(2)(C).
21	(B) Identification of qualifying
22	AGENCIES.—
23	(i) In general.—By not later than
24	180 days after the date of enactment of
25	this Act, the Administrator, after consulta-

1	tion with the Director, shall identify any
2	other agency, entity, office, or commission
3	that the Administrator determines is a
4	qualifying agency for purposes of sub-
5	section $(a)(7)(B)$.
6	(ii) Requirements.—The Adminis-
7	trator shall identify an agency, entity, of-
8	fice, or commission as a qualifying agency
9	if—
10	(I) the agency, entity, office or
11	commission is—
12	(aa) an Executive agency, as
13	defined in section 101 of title 5,
14	United States Code, with human-
15	itarian initiatives; or
16	(bb) an agency, entity, of-
17	fice, or commission with humani-
18	tarian initiatives that is estab-
19	lished in the legislative or judicial
20	branch of the Federal Govern-
21	ment; and
22	(II) the Administrator deter-
23	mines such identification is appro-
24	priate to meet the humanitarian oper-

1	ations needs of the Federal Govern-
2	ment.
3	(iii) Special consideration.—In
4	making the determination under clause
5	(ii)(II) with respect to an agency, entity,
6	office, or commission, the Administrator
7	shall give special consideration to the do-
8	mestic relief work carried out by the agen-
9	cy, entity, office, or commission.
10	(C) Identification of qualifying or-
11	GANIZATIONS OR NONGOVERNMENTAL AGEN-
12	CIES.—
13	(i) In general.—By not later than
14	180 days after the date of enactment of
15	this Act, the Administrator, after consulta-
16	tion with the Director, shall identify orga-
17	nizations and nonprofit agencies that qual-
18	ify to participate in the Humanitarian
19	Tech Corps program, in accordance with
20	subsection (a)(9) and based on the criteria
21	described in clause (ii).
22	(ii) Requirements.—In order to be
23	qualified for purposes of clause (i), an or-
24	ganization or nonprofit agency shall—

1	(I) be a partner of the United
2	States Agency for International Devel-
3	opment;
4	(II) serve humanitarian objec-
5	tives; and
6	(III) meet any other require-
7	ments determined necessary by the
8	Administrator to achieve the purposes
9	of this section.
10	(D) Provision of assistance to the
11	DIRECTOR.—By not later than 180 days after
12	the date of enactment of this Act, the Adminis-
13	trator shall provide the Director with—
14	(i) the definitions described in sub-
15	paragraph (A)(i);
16	(ii) a list of the covered degrees in ac-
17	cordance with subparagraph (A)(iii);
18	(iii) a list of the qualifying agencies
19	identified under subparagraph (B); and
20	(iv) a list of the organizations and
21	nonprofit agencies identified as qualifying
22	organizations or nongovernmental agencies
23	under subparagraph (C).
24	(E) UPDATES.—On not less than an an-
25	nual basis, the Administrator shall—

1	(i) review the determinations made
2	under subparagraphs (A), (B), and (C);
3	(ii) update any such determinations as
4	needed; and
5	(iii) provide any such updated deter-
6	minations, or updated definitions or lists
7	described in subparagraph (D), to the Di-
8	rector.
9	(F) Additional assistance.—In addi-
10	tion to the assistance provided under subpara-
11	graphs (A) through (E), the Administrator
12	shall, upon request by the Director, assist the
13	Director with respect to any other aspects of
14	the Humanitarian Tech Corps scholarship pro-
15	gram that relate to humanitarian operations, in
16	order to enable the Director to be able to focus
17	on technology talent pipeline development
18	through the program.
19	(2) DIRECTOR DUTIES.—The Director shall an-
20	nually consult with the Administrator—
21	(A) regarding the implementation of the
22	Humanitarian Tech Corps scholarship program;
23	and
24	(B) to review—

1	(i) the scholarship recipient selection
2	process for the preceding year; and
3	(ii) the ability of the United States
4	Agency for International Development to
5	provide recommendations regarding the
6	Humanitarian Tech Corps program to the
7	National Science Foundation for future se-
8	lection cycles.
