(1) In general.—In carrying out the commu-1 2 nications program required under subsection (a), the 3 Under Secretary shall maintain a working group for 4 the purpose of identifying the most effective ways to 5 disseminate information about changing weather 6 patterns and risks associated with such changes, in-7 cluding public campaigns, educational resources for 8 community and local leaders, and outreach to key 9 decision makers and educators in local government 10 and community organizations. 11 (2) Makeup and organization.—The Under 12 Secretary shall determine the makeup and organiza-13 tion of the working group required under paragraph 14 (1).15 (3) Support services.—The working group 16 required under paragraph (1) shall coordinate with 17 existing programs engaged in weather and climate 18 communication and the provision of operational cli-19 mate services, including the impact-based decision 20 support services of the National Weather Service. 21 (d) Funding.—There are authorized to be appro-22 priated to the National Oceanic and Atmospheric Adminis-23 tration \$3,000,000 for each of fiscal years 2025 through 2028 to carry out this section.
